Inaugural Session: Leadership for Future

Time: 1000 - 1100 hrs (IST)

Session Theme: The world has quite successfully survived, then revived and now thrived by finding opportunities in the recent disruptions. With it came a sense of urgency to ideate, improvise and innovate, to nurture new economic models and partnerships to 'reimagine the world'. This transformation was driven by technology led innovations transcending space and time, leading to cross fertilization of knowledge and ideas at a never-before pace.

Global leaders continue to strive for excellence to make their business resilient and adaptable in an environment where change is the only constant. They look at future global partnerships, through the prism of sustainability and gender diversity.

Plenary session 1: Excellence in Manufacturing Time: 1100 – 1200 hrs (IST)

Session Theme: In the "VUCA times", manufacturing has undergone a radical transition from being labor intensive to technology centric. Global leaders are re-imagining sustainable manufacturing processes using clean technologies, IOT, and circularity through an 'extended product responsibility'. Impact of greater participation of women in manufacturing arena, would be an interesting aspect of discussion. The session would also aim to understand the international best practises and unveil imperatives for businesses to become an integral part of global manufacturing value chains. Plenary session 2: Food for All: From Farm to Fork

Time: 1200 - 1300 hrs (IST)

Session Theme: It is estimated that by 2050 there will be nearly 10 billion people on Earth. We will need to produce 70% more food. Meanwhile, agriculture's share of global GDP has shrunk to just 3%, one-third its contribution just decades ago. Under a business-as-usual scenario, 8 percent of the world's population (or 650 million) will be undernourished by 2030 itself. The challenge gets intensified due to agriculture's extreme vulnerability to climate change and other disruptions. Feeding 10 billion people sustainably by 2050, would require closing three gaps i.e. food gap between crop calories; land gap between global agricultural land area currently and what is required by 2050; and sustainability gap between expected agricultural emissions in 2050 and the target level needed to hold global warming below 2° C (3.6°F). The acute water resource crunch will add to our woes.

The session on "Food for all: From Farm to Fork" during LEADS 2022 aims to bring together Policy Makers and Agricultural sector community globally, to evolve the roadmap for a viable global framework to support 'farm to fork'. This session will showcase global best practices, and the salutary effect of engagement of women in the agriculture value chain.

The session will be experiential in nature as these global leaders are expected to share their own success stories and learnings.

Plenary session 3: Clean & Green Globe

Time: 1500 - 1600 hrs (IST)
